

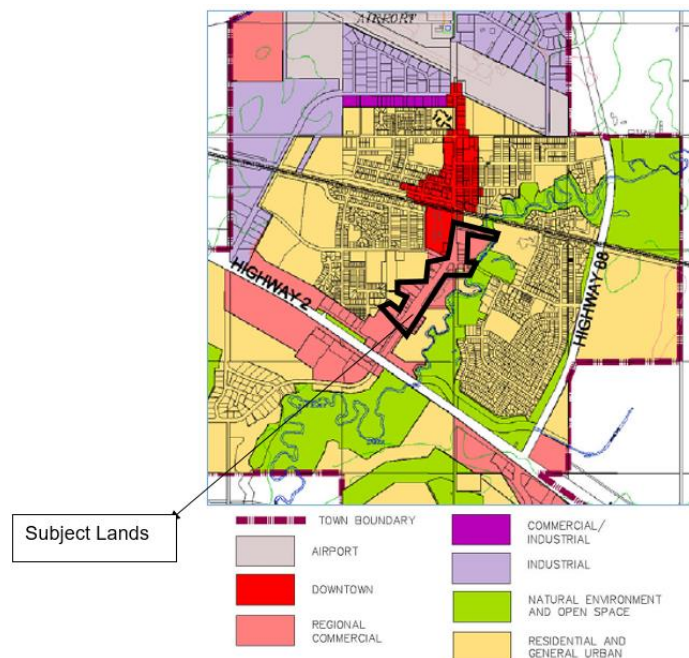


**PUBLIC HEARING**
