## **CHECK LIST OF REQUIREMENTS FOR CONDOMINIUM CONVERSION APPLICATIONS**

In order to comply with Section 8 (1) (b) (ii) of the Condominium Property Act, please be advised that the following information is required:

1. Complete and sign the Application for Condominium Conversion.
2. Submit the Plan of Condominium, prepared by a registered Alberta Land Surveyor, in accordance with the Condominium Property Act, the Condominium General Regulations (Alberta Regulations 89/85) and other considerations required by the Registrar of the Alberta Land Titles Office.
3. Submit a copy of the Plan of Condominium showing the location and number of on-site parking stalls. If the conversion is for a residential use, a list of the number of bedrooms per unit is required, and the corresponding suite number for each proposed unit. If the building is for commercial/industrial use, the gross floor area of the building is required with the Plan of Condominium.
4. Submit a copy of the original approved Development and Building Permits.
5. Submit a copy of the Certificate of Title for the property, together with copies of any instruments, caveats or covenants in the interest of the Town of Slave Lake.
6. Submit payment for the Condominium Conversion application fee to the Town of Slave Lake.
7. If the building was constructed before August 1966, a Building Inspection Report is also required.
