

**BYLAW #10-2002  
TOWN OF SLAVE LAKE**

A BY-LAW OF THE TOWN OF SLAVE LAKE IN THE PROVINCE OF ALBERTA. THIS BY-LAW AUTHORIZES THE COUNCIL OF THE MUNICIPALITY TO PROCEED WITH A DUST CONTROL PROGRAM. THIS BY-LAW FURTHER AUTHORIZES THE IMPOSITION OF A SPECIAL TAX UPON THOSE PROPERTIES NOTED IN SCHEDULES "A", "B", "C", "D", "E", "F", "G", "H", "I", "J", "K", AND "L" ATTACHED TO AND FORMING PART OF THIS BY-LAW.

WHEREAS: the Council of the Town of Slave Lake has decided to pass a by-law pursuant to Section 382 of the Municipal Government Act to authorize the undertaking and completing of the 2002 Dust Control Program (The Project).

The Town of Slave Lake has made plans, specifications and estimates for The Project and confirms the total cost of the said Project is \$32,580.00.

The Council of the Town of Slave Lake has estimated the following contributions will be received or applied to The Project:

1. Special Tax Charges - \$17,781.11
2. Town of Slave Lake - \$12,593.71

The cost of that portion of The Project, which will be raised by special tax, will be spread over a period as indicated in attached schedules.

The estimated lifetime of The Project is one (1) year.

The proposed construction will serve about 11,348.08 assessable meters of frontage.

All required approvals for The Project have been obtained and The Project is in compliance with all acts and regulations of the Province of Alberta.

The Council of the Town of Slave Lake has given proper notice of intention to undertake and complete the Dust Control Program, the costs or a portion of the costs thereof to be assessed against abutting owners in accordance with the attached Schedules "A", "B", "C", "D", "E", "F", "G", "H", "I", "J", "K" and "L".

NOW THEREFORE, THE COUNCIL OF THE TOWN OF SLAVE LAKE DULY ASSEMBLED ENACTS AS FOLLOWS:

Funding

1. That for the purpose of The Project, the sum of \$12,593.71 is to be paid by the Town of Slave Lake at large.

Special Tax

2. There is hereby a special tax in one annual payment, for one (1) year, upon all properties fronting or abutting The Project as set out in Schedules "A", "B", "C", "D", "E", "F", "G", "H", "I", "J", "K" and "L".
3. The special tax shall be based on each unit of frontage abutting or fronting The Project and shall be payable by the owner of the parcel fronting or abutting The Project.
4. The special tax raised shall be sufficient to pay the owners portion of the cost of The Project thereon payable at the unit rate set forth in the Schedules.
5. The special tax imposed hereunder shall be in addition to all other rates and taxes imposed by the Town.
6. Schedules "A", "B", "C", "D", "E", "F", "G", "H", "I", "J", "K" and "L" attached shall be part of this by-law.
7. This bylaw shall take effect on the day of final passing thereof.


