

**BYLAW # 10-2001**

**TOWN OF SLAVE LAKE**

A BYLAW OF THE TOWN OF SLAVE LAKE IN THE PROVINCE OF ALBERTA FOR THE PURPOSE OF CLOSING A ROADWAY IN ACCORDANCE WITH THE PROVISIONS OF THE MUNICIPAL GOVERNMENT ACT.

Pursuant to Section 22 of the Municipal Government Act being Chapter M-26 of the Revised Statutes of Alberta, 1994, as amended, the Municipal Council of the Town of Slave Lake, duly assembled, enacts as follows:

1. That the portion of roadway described in this Bylaw is no longer required for public travel.
2. That application has been made to Council to close said portion of the roadway for consolidation with adjacent residential parcels.
3. That alternate access will be provided, by way of a registered Road Plan, to replace the portion of the roadway to be closed.
4. That notice of the intention of Council to pass this Bylaw was mailed to the registered or assessed owners of land abutting any portion of the roadway to be closed.
5. That notice of the intention of Council to pass this Bylaw was advertised in accordance with Section 606 of the Municipal Government Act and a Public Hearing on the Bylaw was held in the Town of Slave Lake.
6. That Council did not receive any petition or request to be heard from any person or persons claiming to be affected prejudicially by this Bylaw.
7. That Council for the Town of Slave Lake hereby close the following described roadway, subject to any rights of access granted by any other legislation or regulation:
  - a. That portion of the surveyed road allowance between the NW $\frac{1}{4}$  of Section 25, Township 72, Range 6, West of the 5<sup>th</sup> Meridian and the NE $\frac{1}{4}$  of Section 26, Township 72, Range 6, West of the 5<sup>th</sup> Meridian bordering Lot 1, Block 3, Plan 942 0209; and
  - b. That portion of the surveyed road allowance between the NW $\frac{1}{4}$  of Section 25, Township 72, Range 6, West of the 5<sup>th</sup> Meridian and the NE $\frac{1}{4}$  of Section 26, Township 72, Range 6, West of the 5<sup>th</sup> Meridian bordering Lot A, Plan 942 0209,
- As shown on the attached sketch plan marked as Schedule "A" and forming part of this Bylaw.
8. That this Bylaw comes into effect upon the date of its Third and Final Reading.






