



BYLAW NO. 05-2024

BEING A BYLAW OF TOWN OF SLAVE LAKE IN THE PROVINCE OF ALBERTA

A Bylaw of the Town of Slave Lake, in the Province of Alberta for the purpose of establishing the position of Municipal Assessor for the Town of Slave Lake.

WHEREAS Section 285 of the Municipal Government Act, RSA 2000, Chapter M-26 and amendments thereto requires the Town of Slave Lake to prepare an annual assessment of all properties in the Town of Slave Lake.

AND WHEREAS Section 210(1) of the Municipal Government Act, RSA 2000, Chapter M-26 and amendments thereto allows that a council may by bylaw establish one or more position to carry out the powers, duties and functions of a designated officer under this or any other enactment or bylaw.

AND WHEREAS Section 289(1) of the Municipal Government Act, RSA 2000, Chapter M-26 and amendments thereto requires that assessments for all property in a municipality, other than linear property, must be prepared by the assessor appointed by the municipality.

THEREFORE, the Council of the Town of Slave Lake, in the Province of Alberta, duly assembled and under the powers conferred upon it by the authority of the Municipal Government Act, RSA 2000, Chapter M-26 and amendments thereto enacts as follows:

1. **CITATION**

- 1.1. This Bylaw may be cited as "Municipal Assessor Bylaw".
- 1.2. Where the provisions of this Bylaw conflict with the provision of any other Bylaw of the Town of Slave Lake, this Bylaw shall prevail.

2. **DEFINITIONS**

- 2.1. Municipal Assessor: The title for the designated officer appointed by this bylaw.

3. **PURPOSE AND APPLICATION**

- 3.1. Powers and Duties of the Municipal Assessor:

- 3.1.1. The municipal assessor or his/her designate shall carry out the terms of this Bylaw.
 - 3.1.2. The powers and duties of a Municipal Assessor is to:
 - 3.1.2.1. Carry out all duties and obligation imposed upon a municipal assessor by the Municipal Government Act, RSA 2000, Chapter M-26 and amendments thereto.



- 3.1.2.2. Carry out all duties and obligations imposed upon a municipal assessor by bylaw or resolution of council or by any other statute,
- 3.1.2.3. regulation or order of the Province of Alberta either prior to or subsequent to the passing of this bylaw.
- 3.1.2.4. Delegate the performance of any duties, powers and obligations of the municipal assessor to such person as the municipal assessor finds appropriate.

3.1.3. Appointment

- 3.1.3.1. Under the authority of the Municipal Government Act, RSA 2000, Chapter M-26 and amendments thereto; Council for the Town of Slave Lake in the Province of Alberta duly assembled appoints Kevin Lawrence of KCL Consulting Incorporated as the Municipal Assessor for the Town of Slave Lake in the Province of Alberta.

4. **GENERAL PROVISIONS**

4.1.1. Severability:

- 4.1.1.1. Should any provision of this bylaw be deemed invalid then that provision shall be severed from this bylaw and such severance will not affect the validity of the remaining portions of this bylaw, except to the extent necessary to give effect to such severance.

4.1.2. Amendments to Bylaw:

- 4.1.2.1. Town Council may by bylaw amend Bylaw 05-2024 from time to time as required.

5. **Passing OF BYLAW**

- 5.1. That this Bylaw comes into effect upon the date of its Third and Final Reading.
