

**TOWN OF SLAVE LAKE**

**BYLAW NO. 06-2024**

**A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE TOWN OF SLAVE LAKE FOR THE 2024 TAXATION YEAR**

**Whereas**, the Town of Slave Lake has prepared and adopted detailed estimates of the municipal revenues and expenditures as required, at the council meeting held on February 13th, 2024; and

**Whereas**, the estimated municipal expenditures and transfers set out in the budget for the Town of Slave Lake for 2023 total \$26,815,418 ; and

**Whereas**, the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$16,946,963 , and the balance of \$9,868,455 is to be raised by general municipal taxation; and

**Whereas**, the requisitions are:

**Whereas**, the Council of the Town of Slave Lake is required each year to levy on the assessed value of all property, tax rates sufficient to meet the estimated expenditures and the requisitions; and

**Whereas**, the Council is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the Municipal Government Act, Chapter M-26, Revised Statutes of Alberta, 2000; and

**Whereas**, the assessed value of all property in the Town of Slave Lake as shown on the assessment roll is:

**NOW THEREFORE** under the authority of the Municipal Government Act, the Council of the Town of Slave Lake, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Municipality of Alberta:
