

**BYLAW #11-2005  
MUNICIPAL DEVELOPMENT PLAN AMENDMENT  
TOWN OF SLAVE LAKE**

**A BYLAW OF THE TOWN OF SLAVE LAKE IN THE PROVINCE OF ALBERTA  
TO AMEND THE MUNICIPAL DEVELOPMENT PLAN BEING BYLAW #16-  
1997.**

Pursuant to the Municipal Government Act being Chapter M-26 of the Revised Statutes of Alberta, 2004, as amended, the Municipal Council of the Town of Slave Lake, duly assembled, enacts as follows:

1. That the Future Land Use Map of the Municipal Development Plan, being Bylaw #16-1997, attached as Schedule "A" and forming part of this bylaw, be amended as follows:

Lots 1, 3, 4, 5, 6, 7, 8, 9, and 10, Block 7, Plan 1915 H.W.

be re-designated from

Downtown Commercial to Residential and Related.

For further clarity, the area highlighted and shown on the attached sketch marked as Schedule "B" and forming part of this Bylaw, identifies the subject property.

2. That this Bylaw comes into effect upon the date of its Third and Final Reading.


