**TOWN OF SLAVE LAKE
BYLAW #16-1999**

A BYLAW OF THE TOWN OF SLAVE LAKE, IN THE PROVINCE OF ALBERTA FOR THE PURPOSES OF CLOSING A PORTION OF A ROADWAY IN ACCORDANCE WITH SECTION 22 OF THE MUNICIPAL GOVERNMENT ACT, R.S.A. 1994 AND AMENDMENTS THERETO.

WHEREAS, the portion of land hereafter described is no longer required for public travel;

AND WHEREAS, application has been made to Council to have the portion of the roadway closed and put up for public tender for INCLUSION WITHIN A PRIVATE MOBILE HOME PARK;

AND WHEREAS, notice of intention of the Council to pass a bylaw has been mailed by registered mail to persons registered or assessed as the owners of the land abutting upon any portion of the roadway so proposed to be closed, at least two weeks before date fixed for the passing of the bylaw;

AND WHEREAS, notice of the intention of the Council has been provided in accordance with Section 606 of the Municipal Government Act and published in the Scope Newspaper on the 24th day of July, 1999 and on the 31st day of July, 1999, the last of such publications being at least two weeks before the date fixed for the passing of the bylaw;

AND WHEREAS, Council was not petitioned for an opportunity to be heard by a person claiming to be prejudicially affected by the bylaw;

NOW THEREFORE, the Council of the Town of Slave Lake does hereby close the following described roadway, subject to any rights of access granted by any other legislation or regulation:

ALL OF 1ST A STREET W. (MUNICIPALLY KNOWS AS 3RD STREET NW)
(SE 1-73-6-5)

2.
PLAN 1683 TR
ALL THAT PORTION OF 1STA STREET W. (MUNICIPALLY KNOWN AS 3RD STREET NW) LYING NORTH OF THE PRODUCTION EASTERLY OF THE SOUTH BOUNDARY OF PLAN 5105 RS.
(SE 1-73-6-5)

EXCEPTING THEREOUT ALL MINES AND MINERALS

And such Road Closure is further delineated on attached Schedule "A".

This bylaw shall come into force and effect from and after the date of third reading thereof.



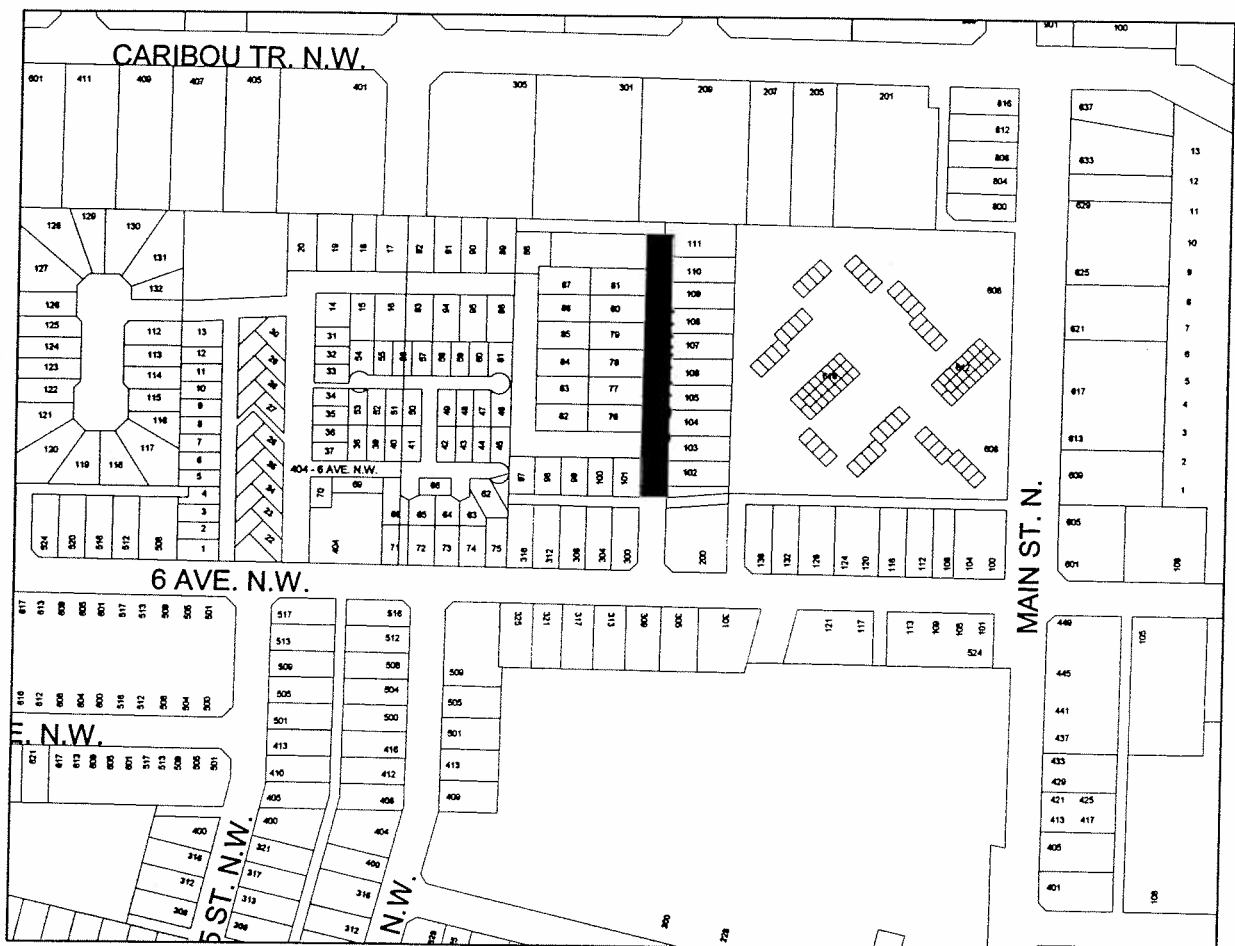
