

BY-LAW #08-1996

TOWN OF SLAVE LAKE

A BY-LAW OF THE TOWN OF SLAVE LAKE IN THE PROVINCE OF ALBERTA TO AMEND BY-LAW #20-1992, THE TOWN OF SLAVE LAKE TRAFFIC BY-LAW AND TO REPEAL BY-LAW #18-1995.

WHEREAS the Highway Traffic Act R.S.A. 1980, C. H-7, provides that a Municipal Council may, by by-law regulate and control vehicle and pedestrian traffic within a municipality;

AND WHEREAS the Municipal Government Act R.S.A. 1994, Chapter M-26.1 provides that a municipality may pass by-laws for the safety, health and welfare of people and the protection of people and property.

NOW THEREFORE the Council of the Town of Slave Lake in the Province of Alberta duly assembled does hereby enact that By-Law #20-1992 be amended to include the following:

222. On Street Construction and Maintenance

- 1. Unless otherwise stipulated or provided for in this By-Law, no person shall, unless he has first obtained a permit from the Director of Operations, perform construction and maintenance work on any highway if the work involves excavation of roadways, sidewalks or boulevards.
- 2. Pursuant to Subsection (1), the Director of Operations may revoke the said permit and require that the highway be made passable to the satisfaction of the Director of Operations.
- 3. In addition to the specified penalty, all work performed without a permit is subject to immediate stoppage and all costs incurred in making the highway passable will be the responsibility of the applicant.

907. 3. Fee for On Street Construction and maintenance (OSCAM) permit is \$50.00.

- 4. Fee for On Street Construction and Maintenance will be based on area of Highway excavated or requiring restoration. The disturbed areas must be accurately described on the OSCAM Permit Application to prevent the possibility of an offence. Inaccurate permits will be considered invalid and the \$500.00 fine for construction without a permit could apply. Fee for On Street Construction and Maintenance is due independent of the permit.


- 5. Fine amount for highway construction without a permit is \$500.00.


6. Alberta Power Limited, AGT, Cable T.V. Slave Lake Ltd. and Northwestern Utilities Limited will not be subject to the preceding clauses. The fore mentioned firms must provide a quarterly report indicating the date, location, type of work and contact person. All work must meet Town Standards for excavation restoration and firms are responsible for deficiencies for a period of two years. This does not dismiss any responsibilities as outlined in the franchise agreements.
7. By-Law #18-1995 is hereby repealed.
8. This by-law shall come into effect upon the date of its third reading.
