

BY-LAW #24-1995

TOWN OF SLAVE LAKE

A BY-LAW OF THE TOWN OF SLAVE LAKE IN THE PROVINCE OF ALBERTA TO AMEND BY-LAWS #5-1975 AND #17-1994 TO PROVIDE FOR THE LEVYING AND COLLECTING OF SERVICE CHARGES, TOLLS AND PENALTIES, OF THE WATER SUPPLY AND DISTRIBUTION SYSTEM AND SEWAGE COLLECTION, REMOVAL AND DISPOSAL OF WASTE.

WHEREAS, it is deemed advisable to amend the by-law of the Town of Slave Lake, in the Province of Alberta which provides for the levying and collection of service charges, tolls and penalties of the water, sanitary sewer, garbage collection and disposal systems:

NOW THEREFORE the Council of the Town of Slave Lake in the Province of Alberta duly assembled does hereby enact:

Section 5 of By-Law #5-1975 amended to read:

1. WATER SERVICE RATES AND CHARGES

- (a) All customers of water from the water system shall be billed on a monthly basis, in accordance with Schedule "A" attached to this By-Law, or billed on a metered basis at rates also set out in Schedule "A".
- (b) Town Council appoints the Director of Engineering and Operations as its duly authorized officer to determine any water that shall be metered.
- © All new construction shall require a water meter prior to receiving services.
- (d) A deposit of one hundred dollars (\$100.00) plus a connection fee of ten dollars (\$10.00) shall be payable in advance of the provision of utility services.
  - I) on any connection made to Town utility lines;
  - ii) upon receipt of notice by the Town of any change of ownership, possession or tenancy of the premises, whether or not reconnection of service is necessary, and
  - iii) upon any connection of service, where the prior disconnection of service resulted from non-payment of accounts.
- (e) If any deposit required to be paid by Section 1(d) of this by-law is not paid, the Town shall not connect the service or shall be at liberty to disconnect the service.

2. Section 6 of By-Law #5-1975 amended to read:

SEWER SERVICE RATES AND CHARGES

All customers of sewage service who are connected to the Town's sewage collection system shall be billed, on a monthly basis in accordance with Schedule "A" attached to the By-Law, or at a minimum monthly charge of seventy percent (70%) of the monthly charge.

3. CHARGES FOR COLLECTION, REMOVAL AND DISPOSAL OF WASTE  
Schedule "A" & "B" of By-Law #29-1993 is amended to change all rates in that By-Law to those shown in Schedules "A" & "B" attached to this By-Law.
4. By-Law #17-1994 and all rates contained therein are hereby rescinded.
5. That this by-law shall take effect after the June 1995 Utility Billing.



SCHEDULE "A"

WATER AND SEWER RATES

The following shall be the monthly water and sewer rates for metered customers:

	<u>Water</u>	<u>Sewer</u>
First 5,000 gallons per month	17.00	See NOTE
Remaining gallons per month	3.00/1,000 gallons	See NOTE

NOTE: A charge equal to 70% of water charges. This charge applies to all rates quoted above.

The following shall be the monthly water and sewer rates for non-metered customers:

Single Family Dwellings, Mobile Homes, Stores and Single Offices,	26.35	28.70	18.45	20.10

Grocery Stores, Pool Rooms, Barbershops, Beauty Salons	41.35	43.70	28.95	30.60
Service Stations, Contractor Services, Office Buildings	62.35	64.00	43.65	45.30
Restaurants/Dining Rooms	77.35	79.70	54.15	55.80

Out-of-town services at double the above rates unless an alternate existing agreement prevails. The Town's Director of Operations shall have the right to decide in what classification a building or service belongs and which customers shall be metered.

Bulk Water Sales - \$7.00/1,000 imperial gallons.

An out-of-town service is a service that is outside the Town limits.

Utility bills of single metered multi-unit developments will be calculated by multiplying the number of units by the base rate plus actual usage.

Customers registered in the volunteer water meter program prior to scheduled increases will benefit by being exempt from the subsequent flat rate increase in water and sewer rates.

SCHEDULE "B"

COLLECTION, REMOVAL AND DISPOSAL OF WASTE RATES

The following shall be the monthly garbage collection and garbage disposal rates level, effective June 1, 1995.

Garbage Collection:

Residential - \$3.50

Garbage Disposal:

Residential - \$5.20

Commercial - \$2.00 per cubic metre

Landfill Fees:

Pickup Load - \$4.00

Single Axle Truck - \$15.00

Tandem Axle Truck - \$20.00

Burner Ash - \$5.98 per cubic metre

Soils, Fill Materials - \$1.00 per cubic metre

Fridges - \$20.00

Stoves - \$10.00
