

**BY-LAW #11-1994**

**TOWN OF SLAVE LAKE**

A BY-LAW OF THE TOWN OF SLAVE LAKE IN THE PROVINCE OF ALBERTA TO AUTHORIZE THE SEVERAL RATES OF TAXATION FOR THE YEAR 1994.

WHEREAS the total requirements of the Town of Slave Lake as shown in the annual estimates, are as follows:

Municipal:

Planning Fund	\$22,000.00

AND WHEREAS the total assessment of land, buildings and improvements amounts to \$213,513,410.00 which \$81,677,230.00 is commercial, and

WHEREAS the estimated revenue other than from taxation is \$2,585,975.00 and

WHEREAS the rates hereinafter set out are deemed necessary to provide the amounts required for municipal, school and other purposes, after making due allowance for the amount of taxes which may reasonably be expected to remain unpaid;

NOW THEREFORE, by virtue of the power conferred upon it by the Municipal Taxation Act, Chapter M-31, R.S.A. 1980, and amendments thereto, the Council of the Town of Slave Lake in the Province of Alberta enacts as follows:

The Secretary-Treasurer is hereby authorized and required to levy the following rates of taxation on the assessed value of all land, buildings and improvements as shown on the assessment and tax roll:






