

BY-LAW #12-1991

OF TOWN OF SLAVE LAKE  
IN THE PROVINCE OF ALBERTA

A By-Law to amend By-Law 19-1989 and amending  
By-Law 28-1989.

WHEREAS final cost to complete the works set out in  
By-Law 19-1989 as amended by By-Law 28-1989 are now known and  
determined,


AND WHEREAS the additional sum of sixty-seven  
thousand (\$67,000.00) dollars is required to complete the portion  
of the work to be paid by the Town at large,

AND WHEREAS the portion of the work to be collected  
by way of special assessment as provided in Schedules A,B,C,E and F  
has not changed.

NOW, THEREFORE, THE MUNICIPAL COUNCIL OF THE TOWN OF  
SLAVE LAKE IN THE PROVINCE OF ALBERTA ASSEMBLED ENACTS AS FOLLOWS:

1. That By-Law 19-1989 as amended by By-Law 28-1989 be amended as  
follows:
  - a) Delete \$3,025,000.00 wherein it appears in By-Law 19-1989  
and insert three million, ninety-two thousand  
(\$3,092,000.00) dollars.
  - b) Delete \$1,756,000.00 wherein it appears in By-Law 19-1989  
and insert one million, eight hundred and twenty-three  
thousand (\$1,823,000.00) dollars.
  - c) Delete \$1,283,000.00 wherein it appears in By-Law 19-1989  
and insert one million, three hundred and fifty thousand  
(\$1,350,000.00) dollars.
2. This By-Law shall take effect on the day of the final passing  
thereof.



IN THE MATTER OF THE "Local Authorities Board Act":

AND IN THE MATTER OF THE "Municipal Government Act":

AND IN THE MATTER OF an application by the Town of Slave Lake for the amendment of Board Order No. 19229.

WHEREAS by By-law No. 19-1989, passed on the 31st day of July, 1989, as amended by By-law No. 28-1989, passed on the 15th day of August, 1989, the Town of Slave Lake, in the Province of Alberta, made application to the Local Authorities Board for authorization to borrow by way of debenture an amount not exceeding the sum of ONE MILLION SEVEN HUNDRED FIFTY-SIX THOUSAND DOLLARS (\$1,756,000.00) for the purpose of street paving, road construction, sidewalks, curb and gutter and upgrading of water supply line:

AND WHEREAS the Board gave its authorization to the aforesaid By-law by Board Order No. 19229, dated the 7th day of September, 1989:

AND WHEREAS due to the increased costs, the Town of Slave Lake has estimated an increase of SIXTY-SEVEN THOUSAND DOLLARS (\$67,000.00) relative to the amount authorized will be required to complete the aforesaid project:

AND WHEREAS by By-law No. 12-1991, passed on the 26th day of February, 1991, the Town of Slave Lake has deemed it expedient to amend the amount to be borrowed by way of debenture pursuant to By-law No. 19-1989 as amended by By-law No. 28-1989:

AND WHEREAS an application has been made to the Local Authorities Board by the Town of Slave Lake for the amendment of the aforesaid Board Order:

THEREFORE the Local Authorities Board HEREBY ORDERS THAT Board Order No. 19229, dated the 7th day of September, 1989, be amended by deleting the words and figure "ONE MILLION SEVEN HUNDRED FIFTY-SIX THOUSAND DOLLARS (\$1,756,000.00)" wherein they appear in the aforesaid Board Order and substituting therefor the words and figure "ONE MILLION EIGHT HUNDRED TWENTY-THREE THOUSAND DOLLARS (\$1,823,000.00)".

Except as hereby amended the said Board Order No. 19229 remains in effect and the same is confirmed.
