

TOWN OF SLAVE LAKE

A BY LAW OF THE TOWN OF SLAVE LAKE IN THE PROVINCE OF ALBERTA, TO AMEND BY LAW #5-1975 AND BY LAW #34-1987, BEING BY LAWS TO PROVIDE FOR THE LEVYING AND COLLECTING OF SERVICE CHARGES, TOLLS AND PENALTIES, OF THE WATER SUPPLY AND DISTRIBUTION SYSTEM AND SEWAGE COLLECTION, REMOVAL, AND DISPOSAL OF WASTE.

WHEREAS, it is deemed advisable to amend the by law of the Town of Slave Lake, in the Province of Alberta which provides for the levying and collection of service charges, tolls and penalties of the water, sanitary sewer, garbage collection and disposal systems:

NOW THEREFORE, the Council of the Town of Slave Lake in the Province of Alberta duly assembled does hereby enact:

1. Section 5 of By-Law #5-1975 amended to read:

WATER SERVICE RATES AND CHARGES

- (a) All customers of water from the water system shall be billed on a monthly basis, in accordance with Schedule "A" attached to this By Law, or billed on a metered basis at rates also set out in Schedule "A".
- (b) Town Council appoints the Director of Operations as it's duly authorized officer to determine any water that shall be metered.

2. Section 6 of By-Law #5-1975 amended to read:

SEWER SERVICE RATES AND CHARGES

All customers of sewage service who are connected to the Town's sewage collection system shall be billed, on a monthly basis in accordance with Schedule "A" attached to this By-Law, or at a minimum monthly charge of sixty-nine percent (69%) of the monthly water charge.

3. CHARGES FOR COLLECTION, REMOVAL AND DISPOSAL OF WASTE:

Schedule "A" of By-Law #34-1987 is amended to change all rates in that by-law to those shown in Schedule "B" attached to this By-Law.

4. By-Law #41-1990 and all rates within By-Laws #34-1987 and #3-1991 are hereby rescinded.

SCHEDULE A - ~~OPTIONAL~~ *3/8*

WATER AND SEWER RATES

The following shall be the monthly water and sewer rates for metered customers:

	Water	Sewer
First 8,000 gal./month	\$21.00	(See NOTE)
Remaining gal./month	2.63/1000 gal.	(See NOTE)

NOTE: A charge equal to 69% of water charges. Applies to all rates quoted above.

The following shall be the monthly water and sewer rates levied for non-metered customers:

	Water	Sewer
Single Family Dwellings, Mobile Homes, Stores and single offices, Halls	21.00	14.50
Apartments (per unit)	15.75	10.88
Grocery Stores, Pool Rooms, Barbershop/Beauty Salon	31.50	21.75
Service Stations, Bunkhouse services, Office Buildings	42.00	29.00
Restaurants/Dining Rooms	63.00	43.50
Beverage Rooms, Car Wash (per bay), Coin Laundry (per machine)	84.00	58.00
Hotel & Motels (per room)	10.50	7.25
Schools (per room)	15.75	10.88

Out of Town services at double the above rates. Town Director of Operations shall have the right to decide in what classification and building or service belongs and which customers are metered.

Bulk water sales - \$6.00 per 1,000 imperial gallons.
An out-of-town service is a service that is outside the town limits.

A ten percent (10%) discount shall be allowed for mobile homes in trailer courts where the trailer court pays a lump sum amount for services to trailers located therein.

The following shall be the monthly garbage collection and garbage disposal rates level, effective January 1, 1992.

Garbage Collection:

7-12 minutes/pickup	14.80
13-18 minutes/pickup	22.20
19-24 minutes/pickup	29.20

Garbage Disposal:

Residential	\$1.70
Commercial	3.40
