

BY LAW #27-1989

TOWN OF SLAVE LAKE

A BY LAW OF THE TOWN OF SLAVE LAKE IN THE PROVINCE OF ALBERTA FOR THE PURPOSE OF CLOSING AND SELLING A PORTION OF A PUBLIC HIGHWAY IN ACCORDANCE WITH SECTIONS 180 AND 183 OF THE MUNICIPAL GOVERNMENT ACT, CHAPTER M-26 REVISED STATUES OF ALBERTA 1980.

WHEREAS, the lands hereinafter described are no longer required for public travel, and;

WHEREAS, application has been made to the Council of Slave Lake to have the lands herein closed, and;

WHEREAS, notice of intention of the Council of the Town of Slave Lake to pass a by law has been mailed by registered mail to persons registered or assessed as owners of the land abutting upon the portion of the lane so proposed to be closed at least two weeks before the date fixed for the passing of the by law, and;

WHEREAS, notice of intention of the Council of the Town of Slave Lake to pass a by law has been published in the Lakeside Leader Newspaper July 19th and 26th, 1989, the last of such publication being at least two weeks before the day fixed for the passing of the by law, and;

WHEREAS, the Council of the Town of Slave Lake was not petitioned for an opportunity to be heard by any person prejudicially affected by the by law.

NOW THEREFORE, be it resolved that the Council of the Town of Slave Lake does hereby close the following described section of highway subject to the rights of access granted by other legislation or regulations.

All that portion of road lying with the S.W. 6-73-5-5 and which lies between the production Easterly of the North limit of 8th Avenue as shown on Subdivision Plan 688 N.Y. and the production South Easterly of the South West boundary of Lot R-1 (Reserve) Plan 688 N.Y.

The Easterly 16.3 metres (53.5 feet) in perpendicular width throughout of all that portion of the original Government Road Allowance adjoining the West boundary of the S.W. 6-73-5-5 and lying between the production Easterly of the North limit of 8th Avenue as shown on Subdivision Plan 688 N.Y. and the production South Easterly of the South West boundary of Lot R-1 (Reserve) Plan 688 N.Y. Excepting thereout all mines and minerals.

By Law #9-1972 is hereby rescinded.
