

WHEREAS pursuant to Section 61(1) of the Planning Act, being Chapter P-9 of the Revised Statutes of Alberta, 1980 the Council of the Town of Slave Lake in the Province of Alberta (hereinafter called the Council) has passed the General Municipal Plan By-Law #6-1987, and;

WHEREAS the Council deems it desirable that By-Law #6-1987 be amended;


NOW THEREFORE the Council hereby enacts as follows:

1. That Map Two - Future Land Use of By-Law #6-1987 be amended by replacing the future land use patterns for a portion of the Town with those shown in the attached Schedule "A" forming part of this By-Law, described as; Lots 4-10, Block 1, Plan 167 K.S.
2. That Maps Three & Four of By-Law #6-1987 be amended in conformance with Map Two - Future Land Use as amended.






BY-LAW #28-1993

TOWN OF SLAVE LAKE

A BY-LAW OF THE TOWN OF SLAVE LAKE IN THE PROVINCE OF ALBERTA AUTHORIZING THE IMPOSITION OF PENALTIES ON UNPAID TAXES.

WHEREAS, the Council of the Town of Slave Lake deem it expedient to amend the penalty structure authorized by ByLaw No. 39-1990 passed November 27, 1990.

THEREFORE, under the authority of and subject to the provisions of the Municipal Taxation Act, the Council of the Town of Slave Lake hereby enacts:

1. That all taxes levied for any year shall be deemed to have been imposed and shall be deemed to have been due and payable on and from the first day of January of the then current year, unless otherwise expressly directed to be levied.


2. That an amount of TEN PERCENT (10%) shall be added by way of a penalty on any current taxes remaining unpaid after thirty (30) days from the date of mailing the tax notices but not earlier than July 1st in any year, and a further SIX PERCENT (6%) shall be added by way of penalty on any current taxes remaining unpaid after the 1st day of October of the year which they were levied.

3. That a penalty of TEN PERCENT (10%) shall be added to and shall form a part of any taxes remaining unpaid after December 31 of the year in which they were levied, and in each succeeding year so long as the taxes remain unpaid.

4. The above penalty rates apply with respect to the license fees payable under the Municipal Government Act for mobile units.

5. This bylaw shall replace and repeal By-Law 39-1990 shall come into force and effect on January 1, 1994.
