

BY LAW #40 - 1988

TOWN OF SLAVE LAKE

A BY LAW OF THE TOWN OF SLAVE LAKE, IN THE PROVINCE OF ALBERTA, TO AUTHORIZE THE ASSESSOR TO USE THE 1988 ASSESSMENT AND VALUATION OF CERTAIN PROPERTY AS SHOWN ON THE ASSESSMENT ROLL OF THE MUNICIPALITY AS THE ASSESSMENT OR VALUATION OF THAT PROPERTY FOR 1989.

WHEREAS, pursuant to the provisions of Section 28 of the Municipal Taxation Act, being Chapter M-31 of the Revised Statutes of Alberta, 1980, and amendments thereto, the Council may, by law, passed not later than the 31st day of December in any year, authorize the Assessor to use the assessment and valuation of certain property as shown on the assessment roll of the current year as the assessment or valuation of that property for the next following year.

NOW, THEREFORE, the Council of the Town of Slave Lake under the authority and pursuant to the provisions of Section 28 of the Municipal Taxation Act, as amended, DOES HEREBY ENACT AS FOLLOWS:

1. That the municipal assessor is hereby authorized to use the assessment and valuation of all properties as shown on the assessment roll as the assessment or valuation of that property for the taxation year 1989 except for:
 - a. Those properties required to be assessed and valued in accordance with Section 34 and 35 of the Municipal Taxation Act.
 - b. Those properties listed below which have had recent sidewalk and street improvements:
