

TOWN OF SLAVE LAKE

A BY LAW OF THE TOWN OF SLAVE LAKE IN THE PROVINCE OF ALBERTA FOR THE PURPOSE OF CLOSING AND SELLING A PORTION OF A PUBLIC HIGHWAY IN ACCORDANCE WITH SECTIONS 180 AND 183 OF THE MUNICIPAL GOVERNMENT ACT, CHAPTER M-26 REVISED STATUTES OF ALBERTA 1980.

WHEREAS, the lands hereinafter described are no longer required for public travel, and;

WHEREAS, application has been made to the Council of Slave Lake to have the lands herein closed, and;

WHEREAS, notice of intention of the Council of the Town of Slave Lake to pass a by law has been mailed by registered mail to persons registered or assessed as owners of the land abutting upon the portion of the lane so proposed to be closed at least two weeks before the date fixed for the passing of the by law, and;

WHEREAS, notice of intention of the Council of the Town of Slave Lake to pass a by law has been published in the Lakeside Leader Newspaper January 11th and January 18th, 1989, the last of such publication being at least two weeks before the day fixed for the passing of the by law, and;

WHEREAS, the Council of the Town of Slave Lake was not petitioned for an opportunity to be heard by anyone who would be prejudicially affected by the by law.

NOW THEREFORE, be it resolved that the Council of the Town of Slave Lake does hereby close the following described section of highway subject to the rights of access granted by other legislation or regulations.

FIRSTLY

Plan Slave Lake 772 2028

All of 5th St. West and corner cut off's lying south of 1st Ave. South and north of Park Drive (NE 36-72-6-5) excepting thereout all mines and minerals.

SECONDLY

Plan Slave Lake 772 2028

all that portion of 2nd Ave. South and corner cut off's lying east of 5th St. West as shown on said plan and west of the production northerly across 2nd Ave. south of the east boundary of Lot 19, Block 6, Plan 772 2028 (NE 36-72-6-5) excepting thereout all mines and minerals.

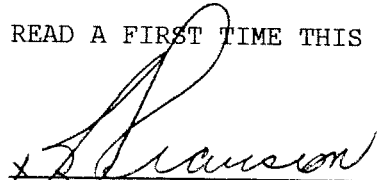

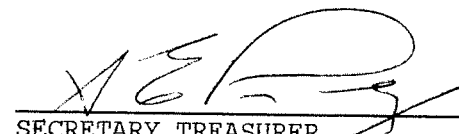
Plan Slave Lake 772 2028

FOURTHLY

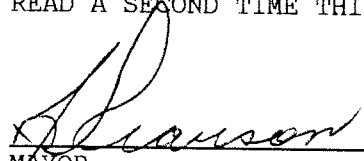
Plan Slave Lake 772 2028, Block 2

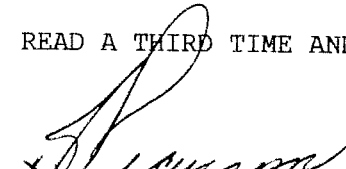

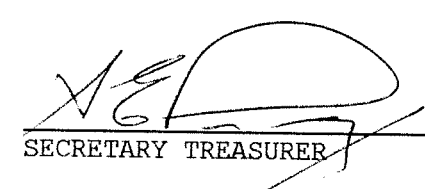

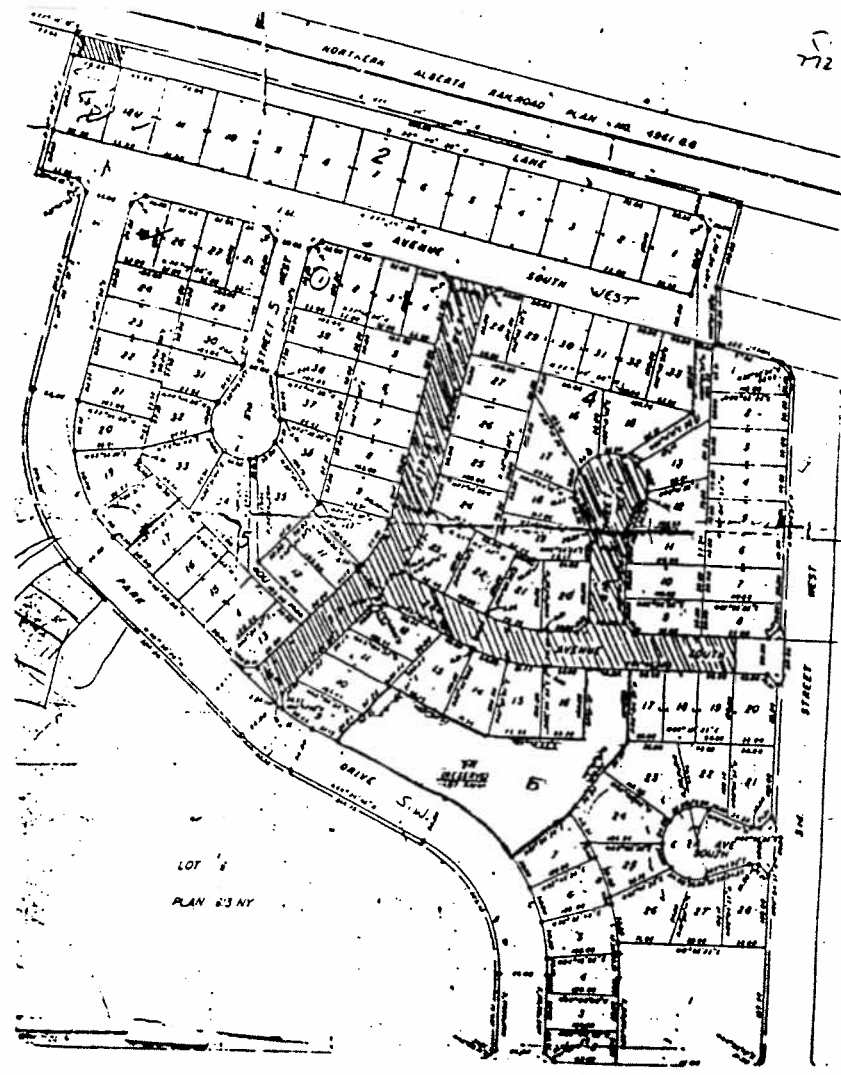
