

BY-LAW NO. 16-1984

TOWN OF SLAVE LAKE

A BY-LAW OF THE TOWN OF SLAVE LAKE IN THE PROVINCE OF ALBERTA FOR THE PURPOSE OF CLOSING AND SELLING A PORTION OF A PUBLIC HIGHWAY IN ACCORDANCE WITH SECTIONS 180 AND 183 OF THE MUNICIPAL GOVERNMENT ACT, CHAPTER M-26, REVISED STATUTES OF ALBERTA 1980.

WHEREAS, the lands hereinafter described are no longer required for public travel; and

WHEREAS, application has been made to the Council to have the lands herein closed; and

WHEREAS, notice of intention of the Council to pass a By-law has been mailed by registered mail to persons registered or assessed as owners of the land abutting upon the portion of 1st Avenue S.W. so proposed to be closed at least two weeks before the date fixed for the passing of the By-law; and

WHEREAS, notice of intention of the Council to pass a By-law has been published in the Lakeside Leader on November 14, 1984 and on November 21, 1984 the last of such publication being at least two weeks before the day fixed for the passing of the By-law; and

WHEREAS, Council was not petitioned for an opportunity to be heard by any person prejudicially affected by the By-law;

NOW THEREFORE, be it resolved that the Council of the Town of Slave Lake does hereby close the following described section of highway subject to the rights of access granted by other legislation or regulations:

All that portion of 1st Avenue South as shown on Subdivisor Plan 871 N.Y. which lies North of the production easterly of the southerly boundary of Lot 2, Block 2, Plan 871 N.Y.
