

BY-LAW 7-1977

A BY-LAW OF THE TOWN OF SLAVE LAKE TO PROVIDE
FOR THE PAYMENT OF A GRANT


UNDER THE AUTHORITY of Section 167 (1) of the Municipal
Government Act, the Council of the Town of Slave Lake duly assembled
enacts as follows:


"That the Council of the Town of Slave Lake grant to

sum of Six Thousand Dollars (\$6,000.00) for the
year of 1977.

Pursuant to the provisions of Section 153 of the Municipal Taxation Act, R.S.Z., 1970 PUBLIC NOTICE IS HEREBY GIVEN that the Council of the Town of Slave Lake intends to undertake the construction of Local Improvements as herein after described, to be paid for by the way of special frontage assessment at Unit Rates per assessable foot per annum as approved by Town Council at the locations hereinafter described.

The proposed local improvements are the construction of the following:

1. Lane paving

At a unit rate of \$2.22 per assessable foot per annum for 5 years.

(Prepaid Cost \$8.40 per assessable foot)

Notice is further given that unless the majority of the owners of the lands that may be assessed therefore, representing at least one-half in value thereof as aforesaid, petition the Council against it within two weeks after the last publication of the Notice, the local improvement may be undertaken and the cost thereof assessed by the system of assessment referred to in this Notice.

If no petition sufficiently signed has, within the time limited in that be half, been presented to the Council against the local improvement or assessment aforementioned, the Council may undertake the proposed local improvement at any time within three years of the giving of the Notice.

All costs in excess of the above Unit Rates will be borne by the Town at large.

Any person requiring information with respect to the proposed local improvement may obtain such information by contacting the Town Office.

NOTE:- The Owners of any lands affected may pay cash for the Improvements at the time of construction or may (pay in cash) at any time any balance of the assessment outstanding pursuant to the Municipal Taxation Act.
