

BY-LAW NO. 8-1977

TOWN OF SLAVE LAKE

A BY-LAW TO AMEND CERTAIN BY-LAWS DEALING
WITH TRAFFIC CONTROL FOR CONVERSION TO
METRIC MEASUREMENT.

Whereas conversion to metric measurement dealing with traffic control will be in force as of and from the First day of September, 1977; and

NOW THEREFORE THE COUNCIL OF THE TOWN OF SLAVE LAKE,
DULY ASSEMBLED ENACTS AS FOLLOWS:

1. The Traffic Control By-Law No. 21-1973 is amended as follows:
 - (a) Section 401, Clauses (d), (e), (f) and (h) are amended by striking out the words and/or figures "15'" wherever they occur and substituting therefor the words and/or figures "5 meters".
 - (b) Section 403, Clauses (a) and (b) are amended by striking out the words and/or figures "500 mm".
 - (c) Section 404, Subsection 1, Clause (b) is amended by striking out the words and/or figures "18'" wherever they occur and substituting therefore the words and/or figures "500 mm".
 - (d) Section 404, Subsection 2 and 3 are amended by striking out the words and/or figures "19'" wherever they occur and substituting therefore the words and/or figures "6 meters".
 - (e) Section 404, Subsection 4 is amended by striking out the words and/or figures "24'" and substituting therefore the words and/or figures "7.5 meters".
 - (f) Section 412, Subsection 2 is amended by striking out the words and/or figures "50'" and substituting therefore the words and/or figures "15 meters".
 - (g) Section 504 is amended by striking out the words and/or figures "15 miles per hour" and substituting therefore the words and/or figures "25 km per hour".
 - (h) Section 505 is amended by striking out the words and/or figures "20 miles per hour" and substituting therefore the words and/or figures "30 km per hour".
 - (i) Section 601, Subsection 1 is amended by striking out the words and/or figures "30 miles per hour" and substituting therefore the words and/or figures "50 km per hour".
 - (j) Section 604 is amended by striking out the words and/or figures "20'" and substituting therefore the words and/or figures "500 mm".
 - (k) Section 903, Clause A(b) is amended by striking out the words and/or figures "42 inches" and substituting therefore the words and/or figures "1.06 meters".
2. By-Law No. 2-1972 respecting "Off-Highway Vehicles" is amended as follows:
 - (9) Section 3, Clause (a) is amended by striking out the words and/or figures "ten (10) miles per hour" and substituting therefore the words and/or figures "15 km per hour".

3. By-Law No. 20-1972 respecting Fire Control is amended as follows:



(a) Section 9, subsection 5 is amended by striking out the words and/or figures "500 feet" and substituting therefore the words and/or figures "150 meters".

4. By-Law No. 1-1976 respecting Cemetery Control is amended as follows:



(a) Section 10, Clause C is amended by striking out the words and/or figures "Ten miles per hour" and substituting therefore the words and/or figures "15 km per hour".
