

TOWN OF SLAVE LAKE

BY-LAW NO. 14-1977

A By-law of the Town of Slave to authorize entering into a joint agreements with other local authorities and the Slave Lake Ambulance Ltd. to furnish continued ambulance service and authorize the making of a grant for such service.

WHEREAS The Slave Lake Ambulance Ltd. is prepared to supply and continue to provide ambulance service in the Town of Slave Lake and to the Village of Kinuso, parts of Improvement District No. 17, the Sawridge Indian Band and Swan River Indian Band on the basis of being assisted with the operation and maintenance of the said ambulance service

AND WHEREAS It has been indicated that a total grant in a sum not to exceed \$8,000.00 would be provided annually toward the maintenance of the said ambulance service;

AND WHEREAS the Municipal Council of the Town of Slave Lake deem it advisable that the inhabitants of the said Town be provided with ambulance service;

AND WHEREAS for the purpose of determining the grant a population basis is to be used as follows:

NOW THEREFORE the Municipal Council of the Municipality of the Town of Slave Lake duly assembled enacts as follows:

1. That authorization is hereby given to enter into a joint agreement with the Village of Kinuso, parts of Improvement District No. 17, the Sawridge Indian Band and Swan River Indian Band and the Slave Lake Ambulance Ltd. to supply and continue to provide ambulance service
2. That an agreement, with Slave Lake Ambulance Ltd., owner and operator of the ambulance service, be contingent upon the said Slave Lake Ambulance Ltd. undertaking to maintain ambulance service throughout the term of the agreement for the purpose of serving the inhabitants of the Town of Slave Lake.
3. That the agreement be contingent upon grants being made by the other parties of the agreement to Slave Lake Ambulance Ltd. for ambulance service for the years, 1978, 1979, and 1980.
4. That for the same purpose, the Municipal Council of the Town of Slave Lake be and is hereby empowered and authorized to make an annual grant in a sum not to exceed Eight Thousand Dollars (\$8,000.00) to be paid in semi-annual payments of Four Thousand Dollars (\$4,000.00) on or before July 1st and December 31st or a lump sum of \$8,000.00 on or before July 1st of each year to said Slave Lake Ambulance Ltd.
5. That the said Agreement shall come into force and have effect on the 1st day of January, A.D. 1978 and shall terminate on the 31st day of December, A.D. 1980.



READ A FIRST AND SECOND TIME THIS 14th DAY OF DECEMBER, 1977



MEMORANDUM OF AGREEMENT

BETWEEN

THE TOWN OF SLAVE LAKE, VILLAGE OF KINUSO, IMPROVEMENT DISTRICT #17, SAWRIDGE INDIAN BAND AND SWAN RIVER INDIAN BAND

PARTIES OF THE FIRST PART

AND

SLAVE LAKE AMBULANCE LTD.

PARTY OF THE SECOND PART

WHEREAS: ALL PARTIES agree that Ambulance service is a necessary service, and

WHEREAS: ALL PARTIES agree that a subsidy is necessary in order for the service to maintain its present good standard, and

WHEREAS: ALL PARTIES agree that a three year agreement is in their best interest

NOW THEREFORE, this agreement witnesseth that the PARTIES hereby covenant and agree with each other as follows:

1. A subsidy shall be paid to Slave Lake Ambulance Ltd.
2. The subsidy shall be in the amount of \$12,000.00 for the year of 1978 with a 2% increase for each of the years 1979 and 1980.
3. The parties of the first part agree to the following:
 - (a) The subsidy shall be divided equally on a per capita basis amongst the parties of the first part being:

Town of Slave Lake
Village of Kinuso
Improvement District #17
Sawridge Indian Band
Swan River Band

- (b) For the length of the agreement the per capita rating shall be based as follows:

Town of Slave Lake	3,561
Village of Kinuso	300
Improvement District #17	1,653
Sawridge Indian Band	47
Swan River Band	<u>100</u>
TOTAL	5,661

(c) The per capita share for 1978 shall be \$12,000.00 divided by 5,661 (population) which equals \$2.12 per capita.

(d) This per capita share results in the following division of the subsidy for 1978:

Town of Slave Lake	3,561 x \$2.12 =	\$7,549
Village of Kinuso	300 x \$2.12 =	\$ 636
Improvement District #17	1,653 x \$2.12 =	\$3,504
Sawridge Band	47 x \$2.12 =	\$ 99
Swan River Band	100 x \$2.12 =	\$ 212
TOTAL 5,661 x 2.12 =		\$12,000.00

(e) For 1979 the per capita share shall be increased by 2% by all parties and again in 1980 by a further 2%.

(f) All payments will be made by the parties of the first part direct to Slave Lake Ambulance Ltd.

(g) Payments may be made in one lump sum on or before July 1st of each year in which the agreement is in effect or one-half on or before July 1st with the second-half being paid by December 31st of each year in which the agreement is in effect.

4. The party of the second part agrees to the following:

(a) That the subsidy outlined in this agreement will be the only monies requested of the participating parties during the term of the agreement.

(b) That they will provide annual financial statements to all parties to the agreement as soon as possible upon the completion of their fiscal year.

(c) That they will provide the best possible service to the citizens represented by all the parties. This service will be on an equal basis to all citizens represented herein.

(d) That, if for any reason, Slave Lake Ambulance Ltd. is unable to continue providing the service, this agreement to provide a subsidy becomes null and void upon the date of Slave Lake Ambulance ceasing operation.

MEMORANDUM OF AGREEMENT

5. This agreement will come into effect on the 1st day of January, 1978 and will terminate on the 31st day of Decmeber, 1980, unless renewed, renegotiated or extended.
