

BY-LAW NO. 7 - 1976

A BY-LAW TO AUTHORIZE THE MUNICIPAL COUNCIL OF THE TOWN OF SLAVE LAKE TO INCUR AND INDEBTEDNESS ON BEHALF OF THE SAID TOWN BY THE ISSUANCE OF TOWN DEBENTURES FOR THE PURPOSE OF CONSTRUCTION OF SEWER EXTENSIONS.

WHEREAS it is deemed expedient and proper pursuant to the provisions of Section 145 of the Municipal Taxation Act, and Section 315 of the Municipal Government Act, R.S.A., 1970 that the Council shall issue a By-Law to authorize the undertaking and completing the construction of sewer extensions.

AND WHEREAS plans, specifications and estimates for such work have been made by Strong, Lamb and Nelson Ltd. Professional Engineers, whereby the total cost of the said construction is estimated to be \$20,905.00.

AND WHEREAS in order to construct and complete the said project, it will be necessary to borrow the sum of \$20,905.00 on the credit of the Town of Slave Lake, by issuing debentures of the Town as herin provided.

AND WHEREAS the said indebtedness is to be repaid over a period of twenty five (25) years in annual installments, with interest not exceeding Twelve per centum (12%) per annum, payable annually.

AND WHEREAS the amount of the equalized assessment in the Municipality as last determined by the Assessment Equalization Board is \$6,124,680.00

AND WHEREAS the amount of the existing debenture debt of the Town is \$2,109,342.00

AND WHEREAS the proposed construction will serve about 1020 lineal feet of frontage.

AND WHEREAS the estimated life of the project is 25 years.

AND WHEREAS approval of the Director, Division of Pollution Control, Department of the Environment for the proposal as required by the Clean Water Act, or regulations therto, has been obtained under Approval No.

AND WHEREAS the total value of the land to be charged with the said special assessment, according to the last revised assessment roll is \$70,500.00.


WHEREAS pursuant to the provisions of Section 145 of the Municipal Taxation Act and Section 315 of the Municipal Government Act, the Council has given proper notice of intention to undertake and complete the construction of sewer extentions, the costs or a portion of the costs thereof to be assessed against abutting owners and/or other benefitting owners in accordance with the attached Schedule "A" and no signed and valid petition against the said proposals has been received by the Council.


NOW THEREFORE THE MUNICIPAL COUNCIL OF THE TOWN OF SLAVE LAKE IN COUNCIL ASSEMBLED ENACTS AS FOLLOWS:

1. The Municipal Council of the Town of Slave Lake is hereby empowered and authorized to enter into contracts for the purpose of construction of sewer extentions as may be necessary.
2. That for the purpose aforesaid, the sum of Twenty Thousand Nine Hundred and Five Dollars (\$20,905.00) be borrowed by way of debenture on the credit and security of the Town of Slave Lake at large of which amount the sum of \$ Nil is to be paid by the Town at large and \$20,905.00 is to be collected by way of special assessment as herein provided in attached Schedule "A".

3. The debentures to be issued under this By-Law shall be for the said sum of Twenty Thousand Nine Hundred and Five Dollars (\$20,905.00) shall be in denominations of One Hundred Dollars (\$100.00) or any multiple thereof, shall be dated the 1st day of August, 1976, or upon such day as may be appropriate having regard to the date of the borrowing, and shall be issued in such manner that the principal and interest will be combined and be made payable in, as nearly as possible, equal annual installments during the said twenty-five (25) years.
4. The debentures maturing in each of such years shall bear interest during the currency of the debentures, at a rate not exceeding Twelve per centum (12%) per annum, payable annually on the 1st of August in each year, or on such other day in each year as may be appropriate having regard to the borrowing and shall have coupons attached thereto for the payment of principal and interest.
5. The debenture with coupons thereto attached, shall be payable in lawful money of Canada at the Royal Bank of Canada in the Town of Slave Lake, and at such other branches of the said bank as may be appropriate.
6. The said debentures shall be signed by the Mayor and the Secretary-Treasurer of the Town of Slave Lake, and the Secretary-Treasurer shall affix thereto the corporate seal of the Town.
7. The coupons attached to the said debenture shall be signed by the Mayor and the Secretary-Treasurer of the Town and such signatures may be engraved or lithographed.
8. There shall be levied and raised in each year of the debentures hereby authorized the amount necessary to pay the interest falling due in such year on such debentures and in addition thereto the amount required to pay any of such debentures which fall due in each year after applying the special assessment hereinafter provided for, by a rate sufficient therefor on all the rateable property in the said Town and collectible at the same time and in the same manner as other rates.
9. During the currency of the said debentured there shall be raised annually for payment of the owners' portion of the cost and interest thereon by special assessment under the Municipal Taxation Act the respective sums shown as yearly payments on Schedule "A" hereto attached, and there is hereby imposed on all lands fronting or abutting on that portion of the streets or places whereon the said extensions are to be laid, or benefitting therefrom, a special assessment sufficient to cover the owners' portion of the cost of the said work and the interest thereon payable at the unit rate or rates set forth in said Schedule "A". The said special assessment shall be in addition to all other rates and taxes.
10. The said indebtedness is contracted on the credit and security of the Town of Slave Lake at large.
11. The net amount realized by the issue and sale of debentures issued under this By-Law shall be applied only for the purposes for which the indebtedness was created unless otherwise authorized by an Order of the Local Authorities Board.
12. This By-Law shall take effect on the day of the final passing thereof.
