THAT By-Law 19-1973 be amended by substituting Twelve Per Cent
(12%) per Annum for Nine Per Cent (9%) per Annum wherever it
appears in said By-Law 19-1973.

WHEREAS by By-Law No. 19-1973, passed on the 24th day of October, 1973, the Town of Slave Lake made application to the Local Authorities Board for approval of a borrowing by way of debenture for an amount not exceeding the sum of ONE HUNDRED THOUSAND DOLLARS (\$100,000.00) for the purpose of providing extensions to Natural Gas System:

AND WHEREAS the Board gave its approval to the aforesaid By-Law by Board Order No. 6630, dated the 16th day of October, 1973:

AND WHEREAS the Town of Slave Lake issued an amending By-Law No. 12-1975, passed on the 24th day of September, 1975, a copy of which said By-Law has been filed with the Board and which amendment provides for a change in the rate of interest referred to in original By-Law No. 19-1973:

AND WHEREAS it is deemed proper that the Board's authorizing Order No. 6630 should be amended to reflect the aforesaid change in interest rate:

IT IS THEREFORE ORDERED that Board Order No. 6630, dated the 16th day of October, 1973, be amended by deleting the words and figure "not exceeding Nine per centum (9%) per annum" wherein they appear in the aforesaid Order and substituting therefore the words and figure "not exceeding Twelve per centum (12%) per annum".

Except as hereby amended the said Order No. 6630 be and the same is confirmed.
