

A BY-LAW OF THE VILLAGE OF SLAVE LAKE TO AUTHORIZE THE MUNICIPAL COUNCIL OF THE VILLAGE OF SLAVE LAKE TO INCUR AN INDEBTEDNESS ON BEHALF OF THE SAID VILLAGE BY THE ISSUANCE OF DEBENTURES FOR THE PURPOSE OF STREET IMPROVEMENTS.

WHEREAS pursuant to the provisions of Sections 402 and 403 of the Town and Village Act, the Council has received a proper petition and has given proper notice of intention to undertake and complete the construction of street improvements consisting of Curbs, Grading and Associated Drainage Sidewalks; and permanent pavement and Associated Drainage, the costs or a portion of the costs thereof be assessed against abutting owner and/or benefitting owners in accordance with the attached Schedule "A", and no sufficiently signed and valid petition against the proposals has been received by the Council;

AND WHEREAS it has been estimated by W.J. Francis and Associates Consulting Engineers Ltd. that the total cost of the said Street Improvements will be approximately Two Hundred thirty thousand, Eight Hundred Dollars (\$234,800);

AND WHEREAS it is estimated by the Council of the said Village that the undernoted applicable grants and contributions will be received by the Village of Slave Lake;

1. Municipal Loan & Development Fund Forgiveness \$39,133

AND WHEREAS in order to construct Curbs, Grading and Associated Drainage; Side walks; and Permanent Pavement and Associated Drainage work it will be necessary to borrow the sum of Two Hundred thirty Four Thousand Eight Hundred Dollars (\$234,800) less the forgiveness of \$39,133 on the credit of the said Village by issuing debentures of the said Village as herein provided;

AND WHEREAS the said indebtedness is to be repaid over a period of twenty years in consecutive equal annual installments, with interest at not exceeding six (6%) per cent, per annum, payable annually;

AND WHEREAS THE ASSESSED value of the land, buildings and improvements as shown on the last revised assessment roll of the said Village amounts to \$565,170.00;

AND WHEREAS the amount of the gross unmatured debenture debt of the said Village is \$443,827 of which no part of the principal or interest payments are in arrears;

AND WHEREAS the proposed Curbs, Grading and Associated Drainage will serve about 13,755 lineal feet of frontage, the proposed Side walks will serve about 6,540 lineal feet of frontage, and the proposed permanent Pavement and associated Drainage will serve about 4,025 lineal feet of assessable footage;

AND WHEREAS of the aforesaid gross debenture debt the amount of \$443,827.00 calculated as hereunder, is debenture debt affecting the borrowing power of the municipality pursuant to the provisions of Section 421(2) of the Town and Village Act -

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE VILLAGE OF SLAVE LAKE IN COUNCIL DULY ASSEMBLED ENACTS AS FOLLOWS;

1. The Municipal Council of the Village of Slave Lake is hereby empowered and authorized to enter into contracts for the purpose of completing said street improvements as may be necessary.
2. That for the purpose aforesaid the sum of Two Hundred Thirty Four Thousand, Eight Hundred Dollars (\$234,800) be borrowed by the way of debenture on the credit and security of the Village of Slave Lake at large, of which amount the sum of \$37,930.75 is to be paid by the Village at large,

and \$157,736.25 is to be collected by the way of Special assessment as he provided in attached Schedule "A", and \$39,133 is forgiven by use of mone from Municipal Loan & Development Fund.

3. The Debentures to be issued under this by-law shall be for the said sum of One hundred and ninety five Thousand, Six-hundred and Sixty Seven (\$195,667) Dollars shall be in denominations of One Hundred Dollars (\$100) or any multiple thereof, shall be dated the 15th day of September, 1965 o upon such day as may be appropriate having regard to the date of the borring in such manner that the principal and interest will be combined and m payable in, as nearly as possible, equal annual installements during the said twenty (20) years.

4. The debenture matur/ing in each such years shall bear interest dur the currency of the debentures, at a rate not exceeding six per centum (6 per annum, payable annually on the 15th Day of September in each year, o on such other day in each year as may be appropriate having regard to the date of the borrowing, and shall have coupons attached thereto for the pa ment of principal and interest.

5. The debentures with coupons thereto attached, shall be payable in lawful money of Canada at the Royal Bank of Canada in the Village of Slave Lake, and at such other branches of the said bank as may be appropriate.

6. The said debentures shall be signed by the Mayor and the Secretary Treasurer of the Village of Slave Lake and the Secretary-Treasurer shall affix thereto the corporate seal of the said Village.

7. The coupons attached to the said debentures shall be signed by the Mayor and Sachetary-Treasurer of the Village of Slave Lake and such signa may be engraved or lithographed.

8. There shall be levied and raised in each year of the currency of t debentures hereby authorized the amount necessary to pay the interest fal due in such year on such debentures and in addition thereto the ~~amount~~ amount required to pay any of such debentures which fall due in each year after applying the net revenues from the said work and special assessment herein provided for, by a rate sufficient therefor on all rateable proper in the said Village and collectible at the same time and in the same mann as other rates.

9. During the currency of the said Debentures there shall be raised a ually for payment on the owners' portion of the cost and interest thereon special assessment under the Town and Village Act the respective sums shown as yearly payments on Schedule "A" hereto attached, and there is hereby imposed on all lands fronting or abutting on that portion of the streets or places whereupon the said works are to be done, or benefitting therefrom, a special assessment sufficient to cover the owners' portion o the cost of the said work and the interest thereon payable at the unit ta or rates set forth in said Schedule "A". The said special assessment shall be in addition to all other rates and taxes.

10. The said indebtedness is contracted on the credit and security of t Village of Slave Lake at large.

11. The net amount realized by the issue and sale of debentures issued under this by-law shall be spent only for the purpose for which the indel edness was created, unless otherwise authorized by an Order of the Local Authorities Board.

12. This by-law shall take effect on the day of the final passing ther

Application having been made to the Local Authorities Board by the Village of Slave Lake for permission to borrow by way of debenture the sum of ONE HUNDRED AND NINETY-FIVE THOUSAND, SIX HUNDRED AND SIXTY-SEVEN DOLLARS (\$195,667.00) for the purpose of street improvements in accordance with the terms of By-law No. 69, of the said Village, read a first time on the 7th day of July, 1965, a copy of which said By-law has been filed with the Board:

Upon reading the said By-law and the other material filed, IT IS ORDERED that the issue of debentures by the Village of Slave Lake in the amount of ONE HUNDRED AND NINETY-FIVE THOUSAND, SIX HUNDRED AND SIXTY-SEVEN DOLLARS (\$195,667.00) for the purpose above set out and in accordance with the terms of said By-law No. 69 be and the same is hereby approved, subject to the conditions that the debentures shall not be signed nor any money advanced until firm tenders or other acceptable cost estimates have been received, indicating that the work can be done at no greater cost than that indicated in the said By-law.

The debenture or debentures to be issued under the said By-law may be dated upon such day as may be appropriate having regard to the date of the borrowing of the money, may be payable in Twenty (20) annual instalments of principal and may bear interest at a rate not exceeding Six per centum (6%) per annum, payable annually.
