

A BY-LAW TO AUTHORIZE THE PURCHASE OF LAND OUTSIDE  
THE BOUNDARIES OF THE VILLAGE OF SLAVE LAKE.

Under the authority of and pursuant to the provisions of Section 273 of The Town and Village Act, R. S. A. 1955, the Council of the Village of Slave Lake in meeting duly assembled enacts as follows:

1. That the Mayor and Secretary Treasurer of the village are hereby authorized to purchase and to complete all the necessary documents connected therewith, the land described hereunder for use as a recreational grounds:

PT. S.E. - 36 - 72 - 6 - W.5

10 acres

2. That the purchase price of the said lands shall not be in excess of the amount of \$1.00.

3. That this by-law shall have no force nor effect until it has received the approval of the Lieutenant Governor in Council.

The Executive Council has had under consideration the report of the Honourable the Minister of Municipal Affairs, dated November 3rd, 1961, stating that:

WHEREAS the Village of Slave Lake, has submitted By-Law No. 13 which is a by-law to authorize the purchase of ten acres of land, more or less, outside the boundaries of the Village for use as a recreation grounds at a cost of \$1.00; and

WHEREAS the Council is authorized to pass such a by-law subject to the approval of the Lieutenant Governor in Council as provided by section 273, subsection (4) of The Town and Village Act; and

WHEREAS it is not necessary to obtain the approval of the proprietary electors as the expenditure is less than five (5) mills on the net total assessment of land, buildings and improvements and the acquisition does not require the contracting of a debt payable over a period of years; and

WHEREAS the Improvement District No. 124 within whose boundaries the land is situated, has advised it has no objections to the purchase of the land for use as a recreational grounds; and

WHEREAS it is considered advisable that the approval of the Lieutenant Governor in Council be extended for this purpose;

THEREFORE, upon the recommendation of the Honourable the Minister of Municipal Affairs, the Executive Council advises that the Lieutenant Governor in Council,

pursuant to the provisions of The Town and Village Act,  
hereby approves By-law No. 13 of the Village of Slave Lake,  
a copy of which by-law is hereto attached.
