



BYLAW NO. 17-2024

BEING A BYLAW OF TOWN OF SLAVE LAKE IN THE PROVINCE OF ALBERTA

A Bylaw of the Town of Slave Lake, in the Province of Alberta, for the purpose of revising Bylaw #05-2023.

WHEREAS Section 63 of the Municipal Government Act, RSA 2000, c M-26, as amended, provides that a council of a municipality may, by bylaw, revise any of its bylaws or any one or more provisions of them in accordance with that section;

WHEREAS the description of the Road in Bylaw #05-2023 pertaining to the closure is incorrect; and it is advisable to correct that error and revise Bylaw #05-2023 in accordance with section 63 of the Municipal Government Act;

THEREFORE, be it resolved that the Council of the Town of Slave Lake in the Province of Alberta duly assembled hereby enacts:

Revision 1 - Bylaw #17-2024 is revised by deleting the text:

" **COMMENCING** at the southwest corner of Lot 23, Block 10, Plan 0220315,
THENCE northerly to the southeast corner of Lot 22, Block 10, Plan 0220315,
THENCE northeasterly along the southeast boundary of Lot 22 to the northwest corner of Lot 22,

THENCE southeasterly in a straight line to the northwest corner of Lot 23,
THENCE southwesterly along the northwest boundary of Lot 23 to the point of commencement."

and replacing it with "All that portion of Walkway lying within Block 10, Plan 0220315, containing 0.021 ha more or less."

Revision 2 - The title of Bylaw #05-2023 is revised to include the words "Revised Bylaw" in accordance with the Municipal Government Act.

RE: Certification of Amendments proposed in Bylaw #17-2024

In accordance with MGA section 63(4), I, Jeffery Simpson, CAO for the Town of Slave Lake, am writing to certify that the amendment proposed in Bylaw #17-2024 are in accordance with section 63(2)(g) where a bylaw under this section may be amended to "*make changes, without materially affecting the bylaw in principle or substance, to correct clerical, technical, grammatical or typographical errors in a bylaw, to bring out more clearly ... the meaning, or improve the expression of the [by]law.*"

Bylaw #05-2023 requires amendment. After further review by Alberta Land Titles the Bylaw was determined to have an insufficient description of the location of the road that was being closed. Therefore amending Bylaw #17-2024 is required in order to satisfy the requirements of Alberta Land Titles Office to close the road as intended.
